Dennis suggested using the funds to have the town hall used as a hot spot where students could do their online studies. Dennis will check into the fiber optic issue and get the cost to go from there.

Ken gave a undate from the Princeton Fire meeting. The meetings will be quarterly with monthly updates send out.

Travis discussed the well the Dalbo Fired Dept. may purchase for \$50,000. Ken so moved with Dennis the 2<sup>nd</sup> that the board is on board with the idea. Passed.
